PRO JUSTITIA

On this day, 11 June of 1994 at 15:00

I, the undersigned party Willem HAMELINCK, Judicial Police Officer (APJ) of the gendarmerie,
Resident at the Judicial Detachment at Brussels, in civilian clothing;

bring to the attention of your office that pursuant to the dossier described in greater detail in the
margin, at the above time and on the above date, we collected information from the party named
hereafter:

Herman TROG

born in Erondégem on 6/12/1936

domiciled at 9040 Ghent, Jef Crickstraat, 34

The spouse of Pélagie MUREBWAYARE

Within the context of the events in RWANDA, the aforementioned party provided us with the
following information:

- on 06/04/94, during the afternoon, it was announced on the radio that the President would return from
DAR ES SALAAM.

- One of their acquaintances, Mrs. BOVEN (of Zairean origin) was at the swimming pool of the Hotel "VILLAGE URUGWIRO" in KACYIRU on 06/04/94 around 17:00, when she was warned by a captain of the Rwandan army that it was advisable for her to go home since serious things were going to happen.
- In this hotel, there was a pavilion which the President visited very regularly, thus implying that there was a permanent military presence there.
- Behind the CND on the road towards DEUTSCHE WELLE, there was a large area somewhere owned by the President, where the INTERAHAMWE carried out its training.
- During the period when the disturbances had begun, an anonymous pamphlet had circulated which stated that the Belgians were going to "turn Rwanda into a Somalia".
- In the edition of the magazine "KANGURA", which appeared around 2 to 3 weeks before the attack, it had been stated that at least 30 Belgians would be liquidated.
- During the broadcasts of RTLM, on the day following the attack, a type of debate took place between HABYMANA and a woman. This broadcast was rebroadcast several times on that day. It stated that the FPR had shot down the presidential plane with the collaboration of the Belgians. The Rwandans should take revenge and defend themselves. This information was broadcast in the local dialect.
- In another broadcast, it was mentioned that people should not ask themselves who the whites were that they had seen. It was observed that it was Belgians who were in the process of pillaging around GISOZI and GACULIRO.
- On RADIO KIGALI, between 07/04 and 11/04, Mathieu GIRUTZI (MRND) had cried that it was the 10 paras' own fault if they had been killed because they themselves had initiated the attack.

- With regard to the roadblocks around KANOMBE, we were told that they were in the hands of the CDR. These were the ones who had massacred the Tutsis. People who lived in the surrounding area should first make a written declaration to prove that they were not in collusion. They would then have to report to the roadblock daily, and on the second day they were killed with blows from machetes.
